

MILITARY STAR® “Your Holiday Bill Is On Us!” Sweepstakes– Official Rules

Use your MILITARY STAR® card November 1 – December 31, 2021 and be automatically entered into the MILITARY STAR® “Your Holiday Bill Is On Us!” Sweepstakes. Each purchase made with your MILITARY STAR® card during the sweepstakes period counts as one entry. No purchase is necessary to enter or win. A purchase does not increase the chances of winning.

Purchases made with MILITARY STAR® card automatically enter the account holder in the Sweepstakes and prizes are applied to the winner’s MILITARY STAR® account as a statement credit.
